- Assist with referrals to specialists/subspecialists or preventive care services.
- Help obtains assistance for special health-care needs, health education, and financial or other family needs.
- Facilitate intervention for substance use issues, mental health problems, and domestic violence for pregnant women.
- Provide referral to and coordination of prenatal medical care.
- Facilitate early intervention when a concern is identified.
- Certain patients may have a greater need for it. Such patients include:
- Children and adolescents with special healthcare needs.
- Children and adolescents with chronic conditions or those at risk.
- Women with high-risk pregnancies.
- Families with limited resources.

Children and Pregnant Women is a Texas Medicaid benefit for eligible patients who have medical-related needs that might affect their health care. The patients must be eligible for Medicaid and be either:

- A child from birth through age 20 with a health condition or health risk.
- A woman of any age who has a high-risk pregnancy.

Many of these patients have complex needs that range from specialty referrals and medical equipment/supplies to educational, psychosocial, financial and transportation services. Case managers, who are licensed social workers or RNs, help patients and their families find and get these services.

ELIGIBILITY

To qualify for **Targeted Case Management** services, you **MUST** receive Medicaid or be Medicaid eligible. If you get Medicaid or CHIP, you might be able to get extra help with your services through your health plan or your providers.

Program recipients who automatically qualify for:

- Early Childhood Intervention (ECI)
- Individuals with intellectual developmental disabilities (IDD)
- Adults with mental illness (STAR Plus)
- Children and Pregnant Women Program
- Community Living Assistance and Support Services (CLASS)
- Deaf Blind with Multiple Disabilities (DBMD)
- Youth Empowerment Services (YES Waiver)
- Youth with Mental and Physical Disabilities (STAR Kids)



OVERVIEW OF STAR PROGRAMS

- The STAR program uses MCOs to cover acute care services for children, newborns, pregnant women, and some families.
- The STAR Kids program uses MCOs to cover integrated acute care and long-term services and supports (LTSS) for children and adults who are 20 years of age or younger and have a disability.
- The STAR+PLUS program uses MCOs to cover integrated acute care and LTSS for adults who are 65 years of age or older (including those who are dually eligible for Medicare and Medicaid) and adults who are 21 years of age or older and have a disability.
- The STAR Health program uses one MCO-Superior Health Plan to deliver healthcare and dental services to children who are in foster care.
