Your Right to File a Complaint:

The policy of Conroe ISD is that all students be free from bullying, discrimination, harassment, and retaliation. All charges of bullying, discrimination, harassment and retaliation are taken very seriously. The District will make every reasonable effort to handle and respond to complaints filed in a fair, thorough, and just manner. Every reasonable effort will be made to protect the due process rights of victims and alleged offenders.

Where to file:

Complaint forms are available from any counselor or administrator or online. Completed complaint forms should be filed with the principal or other campus administrator.

Instructions:

Use this form to report bullying, harassment (other than sexual harassment), discrimination and retaliation so that school officials may investigate and take appropriate steps to increase your safety. Complete the form providing as much detailed information as possible so that the complaint may be properly investigated. It is important that you report the facts as accurately and completely as possible and that you cooperate fully with the persons designated to investigate your complaint. Confidentiality:

To conduct an investigation in a confidential manner, the school will disclose the contents of your complaint only to those persons who have a need to know. In signing the complaint form, you authorize the disclosure, as needed, of the information you have provided, and may provide in the future, regarding your complaint.

Retaliation prohibited:

Retaliation against a person who files a complaint or who participates in the investigation of a complaint is strictly prohibited and is grounds for disciplinary action in accordance with the *Student Code of Conduct*.
