## Financial Report on Self-Funded Health Insurance – Darrin Rice

Total revenue for January 2023 was \$4,481,923 and total expenses were \$7,120,247, which resulted in a negative fund balance of \$2,638.324. However, one claim was approximately \$3 million, and as a result, the stop loss insurance plan is expected to reimburse the plan a significant portion of the cost. Darrin said that once that occurs, the plan will show a positive balance in the amount of approximately \$300,000 for the month of January, and a positive year-to-date balance of over \$2 million.

# **Health Fair Recap – Jill Bartlett**

Jill shared attendance, exhibitor, and screening statistics from the recent health fair. It was a very successful event with 728 attendees, 70 exhibitors, and lots of health screenings performed by nine different companies. She asked committee members to contact her with recommendations and ideas for next year's fair.

#### **Gallagher Team – Darrin Rice**

Darrin shared that there had been a recent change in our Gallagher benefits consultant team. The team will now be headed up by Derek Eacho, with support from Betty Gwinn. Bree Bily was also introduced as the Pharmacy Account Executive.
